



## JUVENTUS ACADEMY HOUSTON PRIVACY POLICY

This Privacy Policy governs the manner in which Juventus Academy Houston collects, uses, maintains and discloses information collected from users (each, a “User”) of the <http://www.juventusacademyhouston.com> website (“Site”). This privacy policy applies to the Site and all products and services offered by Juventus Academy Houston.

### **Personal identification information**

We may collect personal identification information from Users in a variety of ways in connection with activities, services, features or resources we make available on our Site. Users may be asked for, as appropriate, name, email address, phone number. Users may, however, visit our Site anonymously. We will collect personal identification information from Users only if they voluntarily submit such information to us. Users can always refuse to supply personally identification information, except that it may prevent them from engaging in certain Site related activities.

### **Non-personal identification information**

We may collect non-personal identification information about Users whenever they interact with our Site. Non-personal identification information may include the browser name, the type of computer and technical information about Users means of connection to our Site, such as the operating system and the Internet service providers utilized and other similar information.

### **Web browser cookies**

Our Site may use “cookies” to enhance User experience. User’s web browser places cookies on their hard drive for record-keeping purposes and sometimes to track information about them. User may choose to set their web browser to refuse cookies, or to alert you when cookies are being sent. If they do so, note that some parts of the Site may not function properly.

### **How we use collected information**

Juventus Academy Houston may collect and use Users personal information for the following purposes:

- To improve customer service  
Information you provide helps us respond to your customer service requests and support needs more efficiently.
- To personalize user experience  
We may use information in the aggregate to understand how our Users as a group use the services and resources provided on our Site.
- To improve our Site  
We may use feedback you provide to improve our products and services.
- To send periodic emails  
We may use the email address to respond to their inquiries, questions, and/or other requests.

### **How we protect your information**

We adopt appropriate data collection, storage and processing practices and security measures to protect against unauthorized access, alteration, disclosure or destruction of your personal information, username, password, transaction information and data stored on our Site.

### **Sharing your personal information**

We do not sell, trade, or rent Users personal identification information to others.



**We may share your personal information with:**

- Other associations, groups, or organizations who are affiliated with Juventus Academy Houston, including but not limited to Z Zone Fitness Studio, Houston Youth Soccer Association, Texas Youth Soccer Association, US Soccer Association. These entities will use your personal information in the same way as we can under this policy;
- Third-party vendors and other service providers that perform services on our behalf, as needed to carry out their work for us, which may include identifying and serving targeted advertisements, billing, payment processing, content or service fulfillment, or providing analytic services;
- Business partners who offer a service to you jointly with us;
- Other parties in connection with a merger or similar transaction; and
- Third parties as required by law or subpoena or to if we reasonably believe that such action is necessary to (a) comply with the law and the reasonable requests of law enforcement; (b) to protect the security or integrity of our Website; and/or (c) to exercise or protect the rights, property, or personal safety of Juventus Academy Houston, our members, or others.
